MINUTES OF REGULAR LOGAN EAST RURAL WATER SYSTEM ADVISORY COMMITTEE MEETING 8:00 p.m. May 8th, 2023 Monday LOGAN EAST RURAL WATER SYSTEM OFFICE – OAKLAND, NE

The regular meeting of the Logan East Rural Water System Advisory Committee was called to order by Ron Dierking-Chairman of the Advisory Committee on Monday May 8 2023 at 8:00 p.m. in the Logan East Rural Water System Office Oakland, Nebraska. The Publication of Meeting Notice was printed in the Oakland Independent newspaper on May 4 2023.

The Nebraska Open Meeting Act information is posted by the entrance door.

Roll call was taken with 6 of the 9 committee members present. Present: Dam, Dierking, Johnson, Lydick, Scheer, and Wulf. Absent: Fehrer, Hagerbaumer, & Kruger. Roll call of Lower Elkhorn NRD appointed members. Present: Gary Loftis Absent: Roger Gustafson. Brian Bruckner, LENRD Interim manager was also in attendance.

Dam made the motion & was seconded by Lydick to <u>adopt the agenda</u>. Aye: All. Nay: none. Absent: Fehrer, Hagerbaumer, & Kruger. **MOTION CARRIED**.

Minutes of the April 10, 2023 meeting were read Wulf made the motion and was seconded by Scheer to approve the minutes. Aye: All. Nay: none. Absent: Fehrer, Hagerbaumer, & Kruger. MOTION CARRIED

Income & expense reports were given. 24 customers still owe for March water. Five disconnection letters are due 5-10-2023.

Dam made the motion and was seconded by Wulf to transfer LERWS reserve funds in the amount of \$127,135.49 from First Community Bank Bancroft into the LERWS checking acct at First Northeast Bank to apply towards the Sargent Drilling bill of \$179,398.82 for the rehab of well #3. Aye: Dam, Dierking, Johnson, Lydick, Scheer, and Wulf. Absent: Fehrer, Hagerbaumer, & Kruger. MOTION CARRIED

Lydick made the motion and was seconded by Johnson to purchase four General brand tires from 2nd Street Station in the amount of \$1,203.96 as per quote for the 2019 LERWS pickup. There will be and addition fee for alignment. Aye: Dam, Dierking, Johnson, Lydick, Scheer, and Wulf. Absent: Fehrer, Hagerbaumer, & Kruger. **MOTION CARRIED**

Agenda item #7 (See attached map of the area) A discussion on 4,000 feet of 3"pipe line extension. Twp: 23 Rg:10 Sec 08 along Burt County road 25 that could add an additional 4 possible hook ups to LERWS. This would also help increase pressure to customers east of county road 27. Dam made the motion and was seconded by Scheer to instruct Blahak to visit with people who had inquired in the past and future customers about service in that area. Their cost would be approximately 60 percent of the total cost of the project plus the standard \$3,500 hook up fee. Aye: Dam, Dierking, Johnson, Lydick, Scheer, and Wulf. Absent: Fehrer, Hagerbaumer, & Kruger. MOTION CARRIED

New well search: Lydick made a motion and was seconded by Wolf to proceed with the new well project having Blahak negotiate with Mr. & Mrs. Roy Miller about Sue Lackeys' two recommended well sites. Preferable site A1 with the option of A2 based on the State of Nebraska variances allowed. Sargent Drilling

will be contacted to do the test well work. Aye: Dam, Dierking, Johnson, Lydick, Scheer, and Wulf. Absent: Fehrer, Hagerbaumer, & Kruger. **MOTION CARRIED**

Blahak gave the managers' report (see attached copy). A new box culvert being installed by Burt & Washington Counties along county road A. Twp: 20 Rg: 9 Sec: 21. Will cause LERWS line needing to be deepened under a creek. Pump Shop and River Underground will do the work and the cost will be shared one-third each by each Burt county, Washington county and LERWS. Blahak estimated a total cost of \$15,000.

JJ Johansen reported good results from the meetings with fire chiefs. At the meetings in Washington & Dodge counties JJ explained what type of hydrants can be opened & the wrench needed to open them. Dispatchers from all three county will notify Logan East when hydrants are being used.

The next meeting will be June 12, 2023 at the LERWS office in Oakland at 8:00 p.m.

Being no further business Dierking adjourned the meeting at 10:14 p.m.
