The PrairieLand RC&D report was given by Chris Carlson, the Northeast Nebraska RC&D report was given by Stan Baier and Gary Loftis gave the Loess Hills RC&D report.

The Administrative Report was given by staff employees.

The Logan East Rural Water System Advisory Committee report was given by RWS Manager Shawn Blahak. Motion was made by Loftis and seconded by Anderson <u>to accept the Logan East Rural Water System Advisory Committee minutes of July 9, 2012</u>. The Information, Planning & Programs Subcommittee report was given by Subcommittee Chairman Danny Kluthe. Motion was made by Kluthe and seconded by Baier <u>to rescind the following motion that was approved at the regular monthly board meeting on March 22, 2012: "to continue the variance process used for the past three years and allow up to 2500 new irrigated acres on the <u>hydrologically connected area and up to 5000 acres in the non-hydrologically connected area of the district, with an application period from August 1<sup>st</sup> through August 22<sup>nd</sup>, 2012.</u></u>

Extensive discussion was held on the motion by the board and members of the audience.

Motion was made by Anderson and seconded by Hansen <u>to cost share 50% for Phase 1a of the West Point Levee Feasibility Evaluation, not to exceed \$19,625</u>.
