Bob Huntley gave the Northeast Nebraska RC&D report and Gary Loftis gave the Loess Hills RC&D report.

The Bazile Groundwater Management Area Project report was given by Brian Bruckner with a written report by Stephanie Butler included in the packets.

The Administrative Report was given by the staff.

Dave Rus, USGS, updated the directors on the status of the Willow Creek Lake algae study. A final report will be available at a later date.

The Logan East Rural Water System Advisory Committee report was given by Gary Loftis. Motion was made by Loftis and seconded by Zessin <u>to accept the Logan East Rural Water System Advisory Committee minutes of October 13, 2014</u>. The Wau-Col Regional Water System Advisory Committee report was given by Director Garry Anderson. Motion was made by Anderson and seconded by Kluthe <u>to accept the Wau-Col Regional Water System Advisory Committee minutes of October 9, 2014</u>. The Information, Planning & Programs Subcommittee report was given by Subcommittee Chairman Gary Loftis. Motion was made by Loftis to approve the staff recommendation and authorize staff to contract with XRI to perform the proposed helicopter hydrogeologic survey flights, not to exceed \$29,400. Motion died for the lack of a second. (It was noted that XRI had already left the area and was unable to do the flights.)

Motion was made by Loftis and seconded by Shelton <u>to cost share terraces by the cubic yard at 75% of the actual cost up to 75% of the average cost (80% of basin cubic yard cost), up to the limit of 3.5 cy per linear foot of terrace.
