## MINUTES OF LOWER ELKHORN NATURAL RESOURCES DISTRICT BOARD OF DIRECTORS MEETING

The Board of Directors Meeting of the Lower Elkhorn Natural Resources District was called to order by Chairman Danny Kluthe on Thursday, May 26, 2016 at the Lifelong Learning Center, 601 East Benjamin, Norfolk, Nebraska. Chairman Kluthe informed the Board and those attending of the Publication of Meeting Notice in the Norfolk Daily News on May 20, 2016 and the Nebraska Open Meetings Act information posted.

A Public Hearing was held regarding the adoption of amendments to the Lower Elkhorn Natural Resources District Erosion and Sediment Control Program. The Public Notice for the hearing was in the Norfolk Daily News on May 14, 2016, May 18, 2016 and May 23, 2016. No comments were received from the public.

The amendment will:

- 1. Clarify that the statute and program now addresses sediment problems from wind, sheet & rill erosion, and ephemeral or gully erosion as well as water quality problems from pollutants attached to sediments.
- 2. Eliminates the requirement that 90% cost share be available to violators under Administrative order to install conservation practices.
- 3. Standardize administration of the Erosion and Sediment Control Programs across the state by supplying a template to follow.
