The Bazile Groundwater Management Area Project report was received from Assistant Manager Bruckner. He reported that a Risk Communication Workshop for the Bazile Project will be held August 22 and 23.

The Logan East Rural Water System Advisory Committee report was given by Gary Loftis. Motion was made by Loftis and seconded by Barr <u>to accept the Logan East Rural Water System Advisory Committee minutes of July 10, 2017</u>. The Wau-Col Regional Water System Advisory Committee report was given by Jerry Allemann. Motion was made by Allemann and seconded by Hansen <u>to allow the Wausa Rural Fire Department to install their antennae on the Wau-Col (Wausa) RWS tower standoff bracket and that they will have to follow OSHA regulations; all expenses associated with the installation is the responsibility of the Wausa Rural Fire Department. The Committee of the Whole report was given by Vice-Chairman Mike Krueger. A presentation was given on the West Point levee accreditation by West Point City Administrator Tom Goulette, Mayor Marlene Johnson and JEO Consulting Group. The representatives requested cost share assistance for the levee construction phase. Motion was made by Hansen and seconded by Krueger to have the general manager sign an interlocal agreement with the City of West Point to cost share 50% of the construction phase of the West Point levee accreditation project, with an approximate NRD share of the project being \$1,750,000. Motion was made by Krueger and seconded by Hansen <u>to direct the staff to submit a request to</u> <u>the Natural Resources Commission to amend the Lower Elkhorn Water and Soil Conservation Program – Application #4122, which would allow the District to provide up to \$500 cost-share per meter, for the installation of flow meters on high-capacity wells classified for use as commercial/industrial, livestock, public water supply and any series of wells pumping greater than 50 gallons per minute. In addition, the</u>

amendment requests the modification of the agreement to allow for a reduction in the dollar amount to \$250 per flow meter for irrigation wells for any request for assistance received after June 30, 2017.

Motion was made by Krueger and seconded by Huntley <u>To direct the staff to reserve up to</u> \$75,000 of the remaining funds provided by the Lower Elkhorn Water and Soil Conservation Program – <u>Application #4122 to be used to provide cost-share up to \$500 per flow meter for high-capacity wells classified for use as commercial/industrial, livestock, public water supply and any series of wells pumping greater than 50 gallons per minute, and to utilize available unreserved funds to provide cost-share in the amount of \$250 each, for the installation of flow meters on irrigation wells, on a first-come, first-served basis until unreserved funds are exhausted and require installation of flow meters within this category to be installed by December 31, 2017. Motion was made by Krueger and seconded by Loftis to authorize the staff to apply for a FEMA Pre-Disaster Mitigation Grant for the Lower Elkhorn Natural Resources District Hazard Mitigation Plan update and to include the economic analysis of the recreation area sites and the drought management plans for three communities (West Point, Wayne and Norfolk). Motion was made by Huntley and seconded by Hansen to advertise and present the proposed Fiscal year 2017 Budget and Long Range Plan at a Public Hearing, 7:30 p.m., Thursday, August 24, 2017, at the Lower Elkhorn Natural Resources District board room, 601 East Benjamin Ave, Suite 101, Norfolk, Nebraska. Motion Failed as the motion needed 75% approval or 12 aye votes.
