MINUTES OF LOWER ELKHORN NATURAL RESOURCES DISTRICT BOARD OF DIRECTORS MEETING

Prior to the Lower Elkhorn Natural Resources District Board of Directors meeting, a public hearing was held for the Lower Elkhorn Natural Resources District and the Nebraska Department of Natural Resources Voluntary Integrated Management Plan.

The Board of Directors Meeting of the Lower Elkhorn Natural Resources District was called to order by Vice-Chairman Gary Loftis on Thursday, August 23, 2018 at the Lower Elkhorn NRD, 1508 Square Turn Blvd, Norfolk, Nebraska. Vice Chairman Loftis informed the Board and those attending of the Publication of Meeting Notice in the Norfolk Daily News on August 17, 2018 and the Nebraska Open Meetings Act information posted.

The Public Hearing on the Fiscal Year 2019 Budget was held. Notice of the budget hearing was in Norfolk Daily News on August 13, 2018, Wayne Herald on August 16, 2018, and West Point News on August 15, 2018.

The reading and/or action on the minutes of the July 26, 2018 Board of Directors meeting was next on the agenda. Motion was made by Hall and seconded by Huntley that the minutes of the July 26, 2018 Board of Directors meeting be approved. Motion was made by Kathol and seconded by Janke <u>to approve income in the amount of \$145,055.70 and expenses in the amount of \$386,798.38 as printed and distributed</u>. Motion was made by Kathol and seconded by Hall to approve income in the amount of \$81,352.93 and expenses in the amount of \$48,100.77 for the Logan East Rural Water System as printed and distributed. Delegate Loftis will be unable to attend the Alternate Scott McHenry will therefore move into the delegate position. An alternate would need to be voted on.

Nominated for Voting Alternate was Joel Hansen. Nominations Ceased. After ballots were counted it was announced that Director Joel Hansen was elected Voting Alternate. (Hansen - 12)

The Bazile Groundwater Management Area report was given by Assistant Manager Brian Bruckner and is attached to the official minutes.

The Administrative Report was given by General Manager Mike Sousek. (A copy of the report attached to the official minutes.)

The Logan East Rural Water System Advisory Committee report was given by Roger Gustafson. Motion was made by Gustafson and seconded by Hall <u>to accept the Logan East Rural Water System Advisory Committee minutes of August 13, 2018</u>. The Committee of the Whole report was given by Mark Hall. Motion was made by Hall and seconded by Huntley to approve the Pre-Disaster Mitigation (PDM) Grant #PDM 2017-001-NE for the Lower Elkhorn Natural Resources District Multi-Hazard Mitigation Plan and authorize the General Manager to sign any necessary documents for the Grant and instruct the staff to advertise for Requests for Qualifications (RFQ) to complete the update to the District's Multi-Hazard Mitigation Plan. Motion was made by Hall and seconded by McHenry to accept the proposed changes to the Groundwater Management Area Rules and Regulations and to include changes to address concerns provided in testimony to integrate changes into the Rules that will exempt the off-season application of fertilizers when nitrogen is not the largest percentage of the formulation and the total nitrogen applied per acres is less than 25 pounds. Motion was made by Hall and seconded by Huntley <u>to approve the recommended modifications</u> to the score sheets for the Hydrologically Connected or 10/50 Area and the Non-Hydrologically <u>Connected or Non 10/50 Area and to re-authorize the use of the Lower Elkhorn Natural Resources</u> <u>District "Conditions for Approval Policy" for approved variances for the 2019 growing season</u>. Aye: Allemann, Hall, Hansen, Huntley, Kathol, McHenry, Noonan, Steffen, Zimmerman, Loftis. Nay: Gustafson, Janke, Korth. Absent: Barr, Schultz. Motion Carried.

Motion was made by Hall and seconded by McHenry to allow up to 2,500 acres or 451.35 Acre Feet of new depletion, whichever comes first, of new groundwater irrigation development in the Hydrologically Connected or 10/50 Area under the District's standard variance process for 2019; and to allow up to 2,500 acres of new groundwater irrigation development in the Non-Hydrologically Connected or Non 10/50 Area under the District's standard variance process for 2019. As a condition for approval, an annual limit on the amount of groundwater withdrawal from wells associated with approved variances will be determined by board policy, which is subject to future modification if conditions warrant. In addition, a minimum soil score of 90 must be met for any standard variance to be considered for approval. Standard variance requests will also only be considered for approval from areas within the District that fall within the top five Potential for Development categories, as provided by the Classification 4 Map, as provided by Flatwater Group. Also excluded from consideration for this sign-up period will be any parcel of land located in any Lower Elkhorn NRD Phase 3 Area, as determined by trigger levels outlined in the Groundwater Management Area Rules and Regulations, to limit the potential for future contributions to the existing groundwater nitrate conditions. In addition, a District sign-up for the receipt of standard variance requests shall be established between September 4 and October 3, 2018.

Discussion followed.

Moved to amend by Hall and seconded by Korth to remove the sentence: <u>Also excluded from consideration for this sign-up period will be any parcel of land located in any Lower Elkhorn NRD Phase 3 Area, as determined by trigger levels outlined in the Groundwater Management Area Rules and Regulations, to limit the potential for future contributions to the existing groundwater nitrate conditions. Aye: Allemann, Hall, Kathol, Korth, Steffen, Zimmerman, Loftis. Nay: Gustafson, Hansen, Huntley, Janke, McHenry, Noonan. Absent: Barr, Schultz. Amendment Carried.</u>

Vote on Amended Motion: to allow up to 2,500 acres or 451.35 Acre Feet of new depletion, whichever comes first, of new groundwater irrigation development in the Hydrologically Connected or 10/50 Area under the District's standard variance process for 2019; and to allow up to 2,500 acres of new groundwater irrigation development in the Non-Hydrologically Connected or Non 10/50 Area under the District's standard variance process for 2019. As a condition for approval, an annual limit on the amount of groundwater withdrawal from wells associated with approved variances will be determined by board policy, which is subject to future modification if conditions warrant. In addition, a minimum soil score of 90 must be met for any standard variance to be considered for approval. Standard variance requests will also only be considered for approval from areas within the District that fall within the top five Potential for Development categories, as provided by the Classification 4 Map, as provided by Flatwater Group. In addition, a District sign-up for the receipt of standard variance requests shall be established between September 4 and October 3, 2018.
