The Bazile Groundwater Management Area written report is attached to the official minutes.

The Administrative Report was given by General Manager Mike Sousek. (A copy of the report attached to the official minutes.) Introduced to the board was Jeremy Milander who recently began employment with UNL as a Bazile GWMA Extension Coordinator and will be housed at the NRD office.

A Lower Elkhorn NRD Pilot Scale Area Groundwater Model Presentation was led by JEO Consulting Group. (Copy of the presentation attached to the official minutes.) Lalit Jha with JEO Consulting Group opened the discussion and provided some background information and an overview of the project. Dave Hume, P.G. with WSP USA Inc. then provided an explanation of the geologic framework that was developed in support of the modeling efforts. He described the process involved with integrating geologic drill logs from existing well locations in addition to the AEM data collected by Aqua Geo Frameworks into the datasets that support the model. To discuss the outputs associated with several management scenarios, Mahesh Pun and Michael Ou with Long Spring Consulting were present to explain the impacts of a drought scenario and a hypothetical new groundwater use scenario.

The Logan East Rural Water System Advisory Committee report was given by Dennis Schultz.
