The Bazile Groundwater Management Area report was given by Whitney Gappa, Bazile Groundwater Management Area Project Coordinator. A copy of the report is attached to the official minutes.

The Administrative Report was given by General Manager Mike Sousek. A copy is attached to the official minutes.

Jordan Shields, a PhD student with the University of Nebraska Earth and Atmospheric Sciences Department, whose research is funded in part by the Lower Elkhorn Natural Resources District, provided an update on his study "Visualizing and Assessing Nitrogen Contamination in Northeast Nebraska." In his progress update Jordan outlined some of the preparatory work that has been required to digitize and integrate data from the LENRD, static water level information provided by the United States Geological Survey, United States Department of Agriculture soils maps, groundwater quality information from the Nebraska Water Quality Clearinghouse, residual soil nitrate information from the Nebraska Vadose Zone Project, and other publicly available forms of data. Jordan provided an overview of his progress to date and indicated that he will be providing regular updates to the LENRD as the project evolves.

The Logan East Rural Water System Advisory Committee report was given by RWS Manager Shawn Blahak and Roger Gustafson. Motion was made by Gustafson and seconded by Clausen pending legal counsel review, to approve an interlocal agreement between the City of Oakland and the Lower Elkhorn NRD/Logan East Rural Water System, to allow the City of Oakland an Emergency hook up to the Logan East RWS 10" main by connecting to a fire hydrant on the north edge of Oakland. Oakland will pay the costs of a hydrant and installation. Logan East RWS will pay for the meter, backflow devise and hose. Logan East RWS tower levels must be maintained at all times.
