The Board of Directors Meeting of the Lower Elkhorn Natural Resources District was called to order by Board Chairman Matt Steffen on Thursday, January 22, 2026 at the Lower Elkhorn NRD, 1508 Square Turn Blvd., Norfolk, Nebraska. Steffen informed the Board and those attending of the Publication of Meeting Notice in the Norfolk Daily News on January 16, 2026, and of the Nebraska Open Meetings Act information posted on the wall.

Roll call was taken by Programs Coordinator Kristie Freudenburg with 15 of 15 Directors present. Approval of this motion will simultaneously instruct Staff to prepare correspondence to notify all non- approved applicants of the outcome and inform them of possible opportunities to reapply in the future. Approval of this motion will simultaneously instruct staff to prepare correspondence to notify all non-approved applicants of the outcome and inform them of possible opportunities to reapply in the future. Approval of this motion will simultaneously instruct staff to prepare correspondence to notify all non-approved applicants of the outcome and inform them of possible opportunities to reapply in the future.
