Certification of Acres Hearing

The Board of Directors Meeting of the Lower Elkhorn Natural Resources District was called to order by Board Chairman Matt Steffen on Thursday, May 28, 2026 at the Lower Elkhorn NRD, 1508 Square Turn Blvd., Norfolk, Nebraska. Steffen informed the Board and those attending of the Publication of Meeting Notice in the Norfolk Daily News on May 20, 2026, and of the Nebraska Open Meetings Act information posted on the wall.

Roll call was taken by Programs Coordinator Kristie Freudenburg with 11 of 15 Directors present. Members present were Jerry Allemann, Mark Burenheide, Scott Clausen, Roger Gustafson, Andy Hrabanek, Lee Klein, Chad Korth, Gary Loftis, Matt Steffen, Melissa Temple, and Anthony Wisnieski. Jim Aschoff, Mike Fler, Kris Loberg, and Jay Reikofski were absent from the meeting.

Chairman Steffen gave a brief description of the District's hearing rules for the public, staff and Board: the complete hearing rules were posted on the district website and a copy of those rules was available near the entryway to the room; any member of the public would be given the opportunity to appear in person or through their agent and could present any supporting witnesses, evidence, or statements in support of their position; the Chairman would allow the property owner 10 minutes to testify, followed by 5 minutes for each member of the public, followed by testimony from the District staff, concluded with 5 minutes for rebuttal testimony; once an individual hearing had been closed, neither the public nor the staff could present additional information unless requested by the board; discourteous conduct, disorderly conduct, as well as highly repetitious testimony would not be allowed in the hearings; and anyone wishing to contest the staff's preliminary determination of the number of certified irrigated acres for a parcel must indicate their desire to do so by writing the unique parcel ID number for the land they wish to contest on the sign-up sheet.

Motion was made by Clausen and seconded by Loftis at 7:35 p.m. *to open the Certification of Acres Public Hearing as listed on the agenda.* Aye: Allemann, Burenheide, Clausen, Gustafson, Hrabanek, Klein, Korth, Loftis, Temple, Wisnieski, Steffen. Nay: None. Absent: Aschoff, Fler, Loberg, Reikofski. Motion carried

Chairman Steffen accepted into the record Exhibit number 1, the District's Hearing Rules of Procedure; Exhibit number 2, the District's Groundwater Management Area Rules and Regulations; Exhibit number 3, the Public Hearing Notice; and Exhibit number 4, the Unique ID spreadsheet.

Chairman Steffen asked the staff if there are any matters continued from prior public hearings. GIS Specialist Mike Murphy answered that there were none.

Chairman Steffen asked the staff if any requests for continuance were received. Murphy answered that there were none.

Chairman Steffen asked the staff if there were any contested hearings received. Murphy indicated there were none.

At this time, Chairman Steffen handed the meeting over to General Manager Brian Bruckner due to a conflict of interest.

Bruckner stated the district would now consider district board members who have a conflict of interest. A conflict of interest means that either the board member, a member of their immediate family or a business that they have an interest in or has a financial interest in the property to be certified by the district. Bruckner noted that disclosure documents were on file for the impacted board members: Jerry Allemann, Roger Gustafson, and Matt Steffen. The properties were identified on the screen.
