The regular meeting of the Logan East Rural Water System Advisory Committee was called to order by Ron Dierking-chairman on Monday July 14, 2025, The Publication of the Nebraska Open Meeting Act information was printed in the Oakland Independent on July 10, 2025, and is posted by the entrance door.

Rollcall was taken with 8 of the 9 committee members present. Present: Dam, Dierking, Hagerbaumer, Fehrer, Johnson, Kruger, Peterson, Tobin. Absent: none, 1 vacancy remains on the committee. Rollcall of the Lower Elkhorn NRD appointed members Present: Gary Loftis and Brian Bruckner, LENRD general Mgr. Absent: Gustafson

Fehrer made the motion and was seconded by Dam to adopt the agenda. Aye: All Nay: none Absent: none

Laurie Schold read the Minutes of June 9, 2025 meeting and was approved. Aye: All Nay: none Absent: None. MOTION **CARRIED** 

Public comment: Doug Hallum, Lower Elkhorn NRD Water Resources Manager, spoke on his work with the system.

Finance Reports were reviewed & approved. 15 people still owe May 2025 water, 1 disconnect will be made.

The Scribner tower -Shawn reported it appears to be only rainwater in the base pit that was left open. The new 8" line that was installed in February going to the tower failed on June 26, 2025. Water was rerouted through the old line, enacting a *voluntary boil* drinking/cooking water notice to customers getting their water from the Scribner tower. Samples were sent to the state lab and an all clear was given July 3, 2025. Rutjens Construction was called in to do the repairs under warranty and water samples were taken. Water was restored into the new line.

Brian Bruckner reported on meetings sharing the proposed costs for LERWS hookups with the City of Oakland and the Village of Craig.

Bruckner, Blahak, & Dierking attended a special meeting with the Village of Craig officials. Cost estimates for Craig to hook on the LERWS line to purchase water were explained.

Bruckner & Ruckman/Bartlett & West Engineer & LERWS staff held a teleconference with Stave McNulty of the State of Nebraska concerning possible funding options for the Oakland & Craig projects. Bruckner will continue to work hard on this project.

JJ showed the committee updated costs for replacing the scada system including Fontanelle and Scribner sites, along with Oakland tower and wells #1 & #2 with funding options. Dam made the motion and was seconded by Hagerbaumer to recommend to the LENRD <u>Updating the Scada system at a total cost of \$78,569.00, over 5 years. Aye:</u> Dam, Dierking, Hagerbaumer, Fehrer, Johnson, Kruger, Peterson, and Tobin. Nay: none Absent: none. **MOTION CARRIED** (see attached proposal)

Kathy Pearson of Oakland will be the Administrative Assistant for Logan East Rural Water System. Beginning July 28, 2025.

Blahak gave the manager's report. See attached copy.

Having no further business, Dierking adjourned the meeting at 8:25 p.m.
