The regular meeting of the Logan East Rural Water System Advisory Committee was called to order by Gary Kruger-Vice-chairman on Monday March 10, 2025. The Publication of the Nebraska Open Meeting Act information was printed in the Oakland Independent on March 6, 2025, and is posted by the entrance door. 31 people still owe water for January 2025, all disconnection notices have been paid.

Bruckner reported the M.O.U. (Memorandum of Understanding) with the city of Oakland to increase the water quantity for LERWS was approved by the city of Oakland at their February 17, 2025 meeting. The M.O.U. with the Village of Craig will be on their March agenda. Things are moving forward on the M.O.U.'s.

Blahak reported that he has been watching the wet ground under the Scribner tower since the last meeting, today there is water there again. A contract was signed with Maguire Iron in December 2023 but work was never done because the water dried up before Maguire came to do the work. Dam made the motion and was seconded by Fehrer to have Maguire Iron come do the repairs for the \$4,500 contract and also at the same time do the 5-year inspection since the tower will need to be drained for both jobs. Blahak has checked prices with Verizon Cellular for the purchase of new phones for himself and JJ. Dam made the motion and was seconded by Hagerbaumer to purchase two new I-phone 16E at \$599. each. The efficiency test reports done by Sargent Well were reviewed. See attached copy of the report with minutes.

Fehrer asked if the old test well along county road L between road 1 & 3 has been sealed. Blahak reported it has not been completed yet.

Brian Bruckner gave the general manager's report. Bev Lydick has resigned from the Logan East Advisory Committee. LERWS thanks her for her service over the past 15 years of being on the committee. A new LERWS representative for the area east of Hwy 75 will be Mike Tobin.

Bruckner is continuing to investigate federal funding for the Logan East new well project. LERWS will continue to move forward in the search for an additional well.

Bruckner updated the committee on federal cuts affecting the Lower Elkhorn Natural Resource District.

Blahak gave the water manager's report. Blahak has ordered nitrate test kits from Midwest Lab and will begin routine sampling at the wells and out on the system to create a data base on nitrates. NE State Lab Well # 3 yearly nitrate taken in the 1st qtr. was 2.29.

The next meeting will be on April 14, 2025, at 8:00 p.m. at the LERWS office in Oakland Having no further business, Kruger adjourned the meeting at 8:10 p.m.
