The regular meeting of the Logan East Rural Water System Advisory Committee was called to order by Gary Kruger Vic-chairman on Monday May 12 2025. The Publication of the Nebraska Open Meeting Act information was printed in the Oakland Independent on May 8, 2025, and is posted by the entrance door. Rollcall was taken with 6 of the 9 committee members present. Present: Dam, Fehrer, Johnson, Kruger, Peterson, and Tobin. Absent: Dierking & Hagerbaumer. Member Larry Wulf passed away April 14, 2025 after serving 22 years on the LERWS Advisory Committee, he will be greatly missed. A replacement will be named at a future meeting. Rollcall of the Lower Elkhorn NRD appointed members Present: Gary Loftis and Brian Bruckner, LENRD general Mgr. Absent: Gustafson

Fehrer made the motion and was seconded by Tobin to <u>adopt the agenda</u>. Aye: All Nay: none Absent: Dierking & Hagerbaumer.

Mark Peterson read the Minutes of April 14 2025 and approved. Aye: All Nay: none Absent: Dierking & Hagerbaumer. MOTION **CARRIED** 

Public comment: No visitors present

Finance Reports were reviewed & approved. Aye: All Nay: none Absent Dierking & Hagerbaumer. 32 people still owe March 2025 water,4 disconnect letters have been sent.

After discussion on water pressure & volume Blahak assured the committee, a new service would be violable Dam made the motion and was seconded by Fehrer to <u>ratify a new water service to Markus Hamel 2287 County Road E Craig NE Twp: 20 Rg: 9 Sec: 1</u> Aye: Dam, Fehrer, Johnson, Kruger, Tobin and Peterson Nay: none Absent: Dierking & Hagerbaumer **MOTION CARRIED** 

Fehrer made the motion and was seconded by Johnson to <u>ratify a new water service for Rick & Nora Eriksen</u> 2590 CR H Tekamah NE Twp: 20 Rg:10 Sec: 17 Aye: Dam, Fehrer, Johnson, Kruger, Tobin and Peterson Nay: none Absent: Dierking & Hagerbaumer **MOTION CARRIED** 

An update on the Scribner tower: no leaks have been found yet. Maguire Iron has done the tank inspection but did not do any work on the area around the raiser pipe where the leak is suspected. 5-6 feet of dirt will need to be dug out. Brian Bruckner will contact Rutjens Construction-Tilden to see if they could do this work.

The solar panels for battery back up of Scada boxes have been received from the LENRD used surplus. No installation has been done yet,

JJ reported on the issues with signal loss at the Fontanelle tower and booster pumps. Micro Com has made a service call and sent additional parts, but nothing has resolved the problem. Dam made the motion and was seconded by Fehrer to update the Scada box at the Fontanelle tower at an approximate cost of \$1,000. Aye: Dam, Fehrer, Johnson, Kruger, Tobin and Peterson Nay: none Absent: Dierking & Hagerbaumer MOTION CARRIED

Blahak reported on a current water line along the river that has been buried under sand from the flood. Digging has been done twice with no results. There is a possibility of 10 feet of cover over the line. It serves 2 current customers and a new service for Tyler Brummond that was ratified in April 2024 but never installed. Blahak

estimated 2000 feet would need to be replaced if the current line is abandoned. Johnson made the motion and seconded by Dam to replace the 3" line at a cost of \$15,000. Aye: Dam, Fehrer, Johnson, Kruger, Tobin and Peterson Nay: none Absent: Dierking & Hagerbaumer **MOTION CARRIED** 

The City of Oakland has sent a proposed plan for Logan East to consider for the purchase of water. LERWS engineer John Ruckman of Bartlett & West has revied. Bruckner will attend a meeting on May 14, 2025 with the city. See attached copy of the proposed agreement.

Blahak gave the water manager's report. April had a 15% water loss.

The next meeting will be on June 9, 2025, at 8:00 p.m. at the LERWS office in Oakland Having no further business, Kruger adjourned the meeting.

We, the Logan East Rural Water System Advisory Committee, recommend that the Lower Elkhorn NRD accent these minutes.
