Public comment: Jim Olson spoke during the Managers report.

Finance Reports were reviewed & approved. Aye: All Nay: none Absent Peterson.
28 people still owe April 2025 water,3 disconnect letters have been sent.
Rate increase options were handed out. No action was taken at this meeting.
The Fiscal Year 2025 budget spending & income was handed out to the committee. 1st draft of the Fiscal Year 2026 budget was included.

The Scribner tower: was dug near the riser pipe by the Pump Shop, with no leaks found. The tower was filled and chlorinated, and samples will be taken and sent to the state lab before it is put back online. Dierking said to close the hole, it was good to have the tower inspected. Kruger asked if an access point could be possible, they do not think so.

Ruckman of Bartlett & West Engineering has sent updated figures on the cost of LERWS hooking up to Oakland & the costs of Craig hooking onto LERWS. Brian Bruckner asked Craig to hold a special meeting with JEO Craigs engineer to go over cost estimates. The Logan East Rural Water Advisory Committee asked that Bruckner continue to move forward on preliminary costs and conversations with Steve McNulty from the State of Nebraska on possible funding opportunities.

JJ asked the committee to look at the costs of replacing/updating the scada system including Fontanelle and Scibner sites, along with Oakland tower and wells #1 & #2(see attached proposal) and funding options. Fehrer asked the committee to table any action until the July 2025 meeting.

Agenda item # 7 was a discussion on the LERWS meetings time. The meetings will continue in the evenings at 7:00 p.m, with flexible times in May & October.

Jim Olson, Source Water Protection Specialist, was present and explained that he will be working with producers in the LENRD and will focus on the LERWS well-head protection area.

Laurie Schold will be retiring from the Logan East Rural Water System. Advertising to fill the position will start.

Blahak gave the manager's report. He has done some testing for nitrates at the tower sites.

The next meeting will be on July 14, 2025, at 7:00 p.m. at the LERWS office in Oakland Having no further business, Dierking adjourned the meeting at 10 p.m.
