Bruckner updated the board on the progress of the City of Oakland and Village of Craig project. JJ also informed the board on the City of Oakland's progress with the construction of the new water treatment plant being built by the City.

Shawn updated the board on the SCADA upgrades. Bruckner informed the board that he has applied for grant money to help with the cost of the upgrade. Peterson asked about the antennas on the tower and discussion was held.

Shawn informed the board he was approached by the current landowner of the farm ground around the Oakland tower that he would like to build a grain bin at this location. Bruckner is researching easements regarding this property and the water tower. Both will keep the board informed of any updates.

Three bids were presented to the board for purchasing new tires for the 2021 pickup operated by the LEWRS. Discussion held. Peterson made the motion to purchase 4 - 275/60R20 Cooper Discoverer Stronghold AT 10 ply tires from 2<sup>nd</sup> Street Station in Oakland for a total cost of \$1,367.56. Second by Fehrer.
